There will be on-site inspections the day of the event, and if you do not have the appropriate permits completed at least two (2) weeks prior to the event, you may be asked to leave the event.

### INSURANCE REQUIREMENTS

A certificate of General Liability insurance in the amount of \$1,000,000 listing RK Ferraro Enterprises as certificate holder and additional insured to include setup and removal days of the annual PUPSTOCK event. Insurance certificates must be issued in your contract/customer name. If a certificate is not provided by June 1, 2026, PUPSTOCK does not guarantee having a space at the PUPSTOCK event, even if a payment is made. In this event, no refund will be provided to the vendor/exhibitor as they did not fulfill the requirements outlined in this agreement.

### HOURS OF OPERATION

If a sponsor has a physical presence, they are required to be open, operating and adequately staffed during the entire event (12:00pm – 5:00pm). No vehicles will be permitted on-site day of the event between the hours of 10:00am – 5:30pm.
